## The Health Committee and Professional Conduct Committee

The Health Committee considers complaints against chiropractors relating to their mental or physical health. Where the Health Committee upholds a complaint against a chiropractor it may impose a 'Conditions of Practice' order or suspend the chiropractor's registration.

The Professional Conduct Committee considers allegations of personal or professional misconduct or incompetence. Where the Professional Conduct Committee upholds a complaint against a chiropractor it may admonish the chiropractor, impose a 'Conditions of Practice' order, suspend the chiropractor's registration or order the Registrar to remove ("strike off") the chiropractor from the Register.
